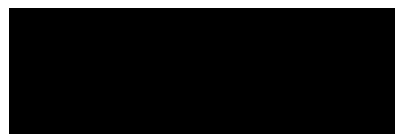

**Drafting notes:**

- This amendment determination amends the *Commerce Act (Specified Airport Services Information Disclosure) Determination 2010 715*, as previously amended ('principal determination'), to make non-material amendments.
- The included amendments which are secondary legislation are made under the Legislation Act 2019 and Part 4 of the Commerce Act 1986.

Under section 52P of the Commerce Act 1986, the Commerce Commission makes the following determination:

**1. TITLE**

1.1. This determination is the Airport Services Information Disclosure (Non-material) Amendment Determination 2026.

**2. INTERPREATION**

2.1. In this determination, the words or phrases in bold type bear the following meaning:

2.1.1. **Principal determination** means the *Commerce Act (Specified Airport Services Information Disclosure) Determination 2010 715*, as previously amended.

**3. DETERMINATION AMENDED**

3.1. This determination amends the **principal determination**.

**4. COMMENCEMENT**

4.1. This determination comes into force on 26 May 2026.

**5. PRINCIPAL DETERMINATION AMENDMENTS**

5.1. In clause 1.4(3) of the **principal determination**, in the definition of “unlevered tax”, replace “less” with “plus”, so the definition reads as follows:

**“unlevered tax** means the **regulatory tax allowance** plus the **notional interest tax shield”**
