Electricity Distribution Services Default Price-Quality Path (Unison Catastrophic Event) Amendment Determination 2025

Under section 52P of the Commerce Act 1986 (**Act**), the Commerce Commission makes the following determination:

1. TITLE

- 1.1 This determination is the Electricity Distribution Services Default Price-Quality Path (Unison Catastrophic Event) Amendment Determination 2025.

2. DETERMINATION AMENDED

- 2.1 This determination amends the Electricity Distribution Services Default Price-Quality Path Determination 2020 [2019] NZCC 21, as amended (**principal determination**).

3. COMMENCEMENT AND APPLICATION

- 3.1 This determination comes into force on [date to add], the day after notice is given in the New Zealand Gazette under the Legislation Act 2019.
- 3.2 Without limiting clause 3.1, amendments to the **principal determination** apply for the DPP regulatory period from 1 April 2020 to 31 March 2025.
