Fibre Deregulation Reviews - Process Update

I am writing to confirm that we have commenced the deregulation reviews resulting from our fibre fixed line access services (FFLAS) reasonable grounds assessment last year.¹

This letter sets out the process we will follow and an indicative timeline for each of these reviews.

Context for the Fibre Deregulation Reviews

We will be conducting deregulation reviews of the following four services:

- Voice services and Transport services for all Local Fibre Companies (LFCs);
 and
- Point-to-point services and Co-location and interconnected services in Non-Chorus LFC areas.

These four services were identified as possible candidates for deregulation in our reasonable grounds assessment last year. We are aiming to make any recommendations to the Minister for Media and Communications before the start of PQP3.²

Process and timeline for the Fibre Deregulation Reviews

The four reviews will move forward in parallel, but on different timelines depending on the anticipated information requirements and complexity of each. We aim to have them all completed by December 2026.

We will approach the review process in a way that ensures that interested parties have the opportunity to participate at each stage of the process. Stakeholders will have opportunities to submit on our draft decisions and, where appropriate, we will provide an opportunity for cross-submissions.

We are not proposing to release issues or emerging views papers at this stage, as we have a good initial understanding of the issues, following the FFLAS reasonable grounds assessment.
